PRIVACY NOTICE

Regarding the Processing of Data for Suppliers and Tender Participants

The company "PIRAEUS CONTAINER TERMINAL SINGLE MEMBER S.A." (PCT S.M.S.A., Neo Ikonio Perama 18863, Contact Details: +30 210 4099100, GDPR@pct.com.gr), hereinafter referred to as "PCT S.M.S.A.", acting as the data controller, respects your privacy and is committed to protecting your personal data. In this context, our company has aligned its Personal Data Protection policy with the applicable legal framework concerning the retention and processing of the personal data you provide. "PCT S.M.S.A." has taken all necessary measures to ensure your data is secure and access to it is restricted in accordance with the law.

Please read the following terms regarding the processing of your data carefully.

1. Purpose of Processing

Your data is processed exclusively for the following purposes:

- Assessment of financial viability and technical capacity.
- Management of supply contracts (e.g., payments, monitoring of obligations).
- Ensuring compliance with legal obligations (e.g., tax declarations).
- Evaluation of offers and selection of supplier/partner.
- Verification of information (e.g., certificates, licenses).
- Transparency and adherence to public procurement rules (where applicable).

2. Legal Basis for Processing

Processing is based on one or more of the following legal bases (Article 6 GDPR):

- Performance of a contract (e.g., supply agreement).
- Compliance with a legal obligation (e.g., adherence to tax rules).
- Legitimate interests pursued by the company (e.g., fraud prevention, ensuring network security).

3. Categories of Personal Data

We collect only the necessary data from the following categories, for the purposes mentioned above:



- Company details (VAT number, registered office, legal representatives).
- Financial details (bank accounts, financial statements).
- Technical/professional details (certificates, CVs/resumes).
- Technical and financial offers (where required).
- Legal documents (e.g., attestations, certificates).
- Contact details (email, phone number).

4. Data Retention

Your data will be retained only for the necessary period, after which it will be securely deleted in accordance with our policy. For supplier data, it will be retained for the duration of the collaboration and for 5 years after its termination (for legal/tax obligations). For data obtained during a tender process, it will be retained for the duration of the process and for 3 years after its completion (for potential objections or reviews).

5. Recipients of Data

Your data may be disclosed only to authorized recipients, who perform only the processing required in each case, such as:

- Internal departments (e.g., finance, procurement).
- External partners (e.g., accountants, legal advisors) bound by data processing agreements (DPAs).
- Public authorities (e.g., tax authorities, National Transparency Authority), only where there is a legal obligation.

6. Transfer to Third Countries

In exceptional cases, your data may be transferred to countries outside the EU/EEA (e.g., for cloud services). In such cases, Standard Contractual Clauses (SCCs) or other safeguards under Article 46 GDPR are applied.

7. Your Rights as a Data Subject

You have the following rights under the GDPR, provided there is no legal reason for restriction:

- Right of access and transparency.
- Right to rectification of inaccurate data.
- Right to erasure ('right to be forgotten') (only if there is no legal basis for retention).
- Right to restriction of processing.



- Right to object to processing based on legitimate interests.
- Right to data portability in a structured format.
